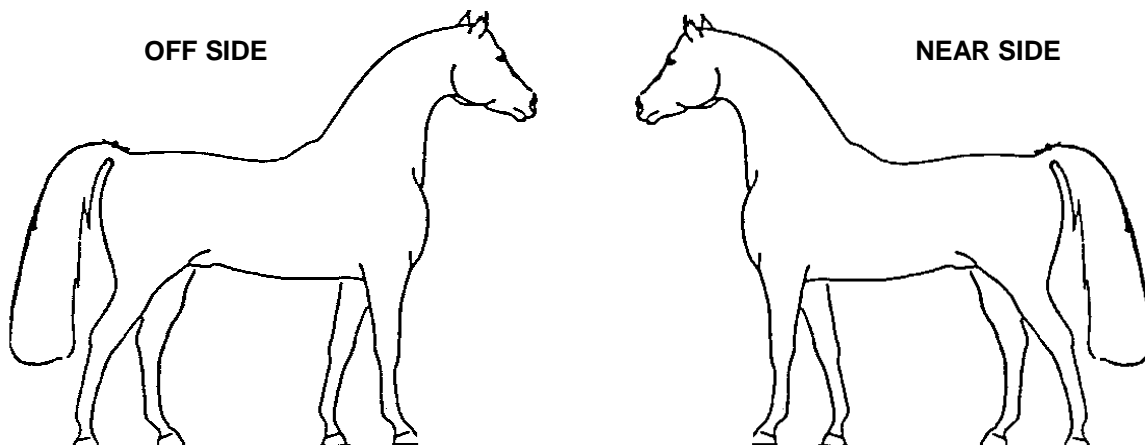

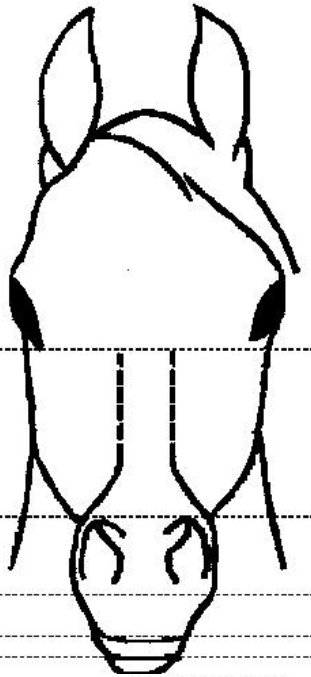

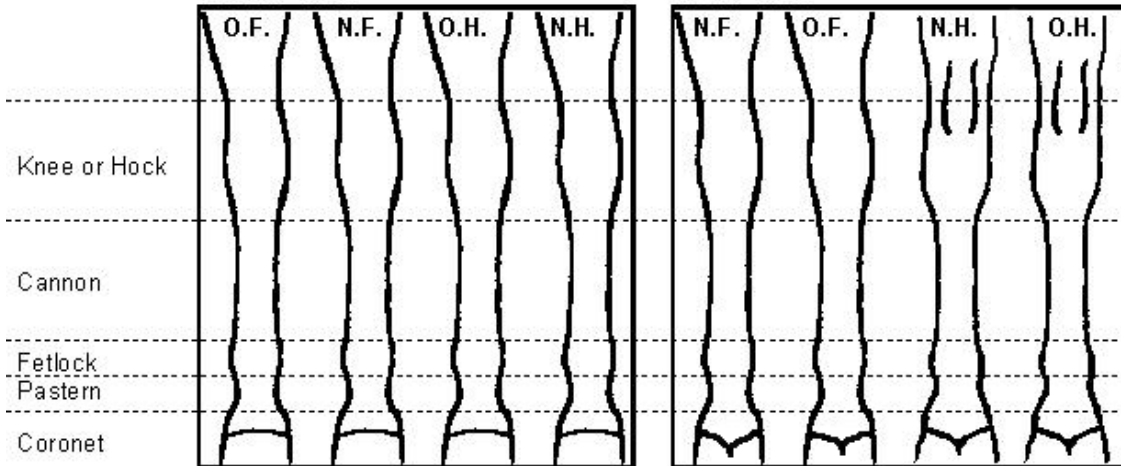

- ◆ Foal Recording is optional.
- ◆ Application must be made and approved within twelve (12) months of date of birth.
- ◆ Owner must be a current financial member of the ASPR Inc.
- ◆ Foal does not have to be the progeny of registered and assessed ASPR Premium Graded sires and/or dams.
- ◆ Pedigree may be known or unknown, dam at least must be disclosed on the application form and certified by the current breeder.
- ◆ Application for foal recording must be made and payment received within twelve (12) months from the date of birth.
- ◆ Foal **must** be presented for assessment on an ASPR assessment tour within **two (2) years** of the date of the foal recording, otherwise the foal recording certificate expires and must be returned to the Registry upon demand.
- ◆ A changeover certificate fee (from Foal Recording to Preliminary Premium Grading) is applicable upon assessment.
- ◆ Foal Recorded ponies/horses completing an ASPR assessment will be issued with a Preliminary Premium Grading, where the score received exceeds 60%
- ◆ Foal Recorded ponies/horses presented for Preliminary Premium Grading are subject to Preliminary Premium Grading By-Laws.
- ◆ Fees payable for foal recording are not refundable and the eligibility to receive an assessment two (2) years from the date of recording remains with the foal registered and is not transferable to another pony, horse or foal.
- ◆ Change of ownership does not prohibit a foal from being assessed on its foal recording certificate, where the new owners membership is current and the new owner remains a financial member of the ASPR at the date of the selected assessment tour.
