OVERHEIGHT APPENDIX REGISTRATION FEE : \$40

- Any mare or stallion over 148 cms without shoes(no maximum) is eligible for listing in the (overheight) Approved Stud Book.
- Geldings are NOT eligible.
- Stallion/Mare must be a minimum of three (3) years of age.
- Owners are required to become a member of the ASPR Inc.
- Horses applying for listing MUST be either previously assessed and registered with the ACE Group or undertake to be assessed on the next ASPR/ACE Group Assessment tour or be assessed/licensed with a stud book approved by the ASPR Inc.
- Microchipping is optional.
- Horse will be measured on assessment date or if previously assessed, MUST provide, with this application, a copy of the ACE Group assessment score sheet or paperwork from the approved stud book.
- Horses accepted into the ASPR Approved Stud Book are NOT eligible for High Point/ROM Awards and cannot compete in competitions specifically for ASPR Premium Graded and Performance Club ponies.

- Photocopies of all registration certificates pertaining to the horse
- If already registered with the ACE Group —copy of assessment score sheet
NB : - 70% and under 80% = OH First Premium
- 80% and above = OH Premier
- If all 4 phases (conformation/in hand, at liberty, ridden and jumping) are completed a * rating will be applied.
- If assessed/licensed with a stud book approved by the ASPR, copies of relevant score sheets and registration certificates.
